#### A GREEN RECOVERY

#### UNIVERSAL BROADBAND

We are investing even more to make sure all Canadians can get high-speed internet. Budget 2021 provides another \$1 billion over six years for the Universal Broadband Fund, in order to support access to high-speed internet by Canadians in rural and remote communities. This investment puts us on track to achieve our 98% high-speed coverage initiative by 2026.

#### **■INFRASTRUC-**TURE

People in Davenport rely on affordable public transit, and it also helps keep our air clean and our emissions lower. In February the federal government announced a historic, firsttime ever permanent public transit fund, and \$14.9B in investments over the next eight years! Budget 2021 lays out how this permanent funding will support new subway lines, streetcars, light rail, bike lanes, electric buses, and so much more!

We are also taking next steps, at long last, to High Frequency Rail in the Toronto-Quebec City corridor with a \$500 million investment!



#### **■ CLIMATE ACTION & INFRASTRUCTURE**

Urgent, bold new climate action is a core part of our federal government's plan to create one million jobs by the end of the year.

Our federal government not only remains committed to our climate goals, but also to increasing our ambition. Even with COVID, climate change remains an existential threat. On Earth Day 2021, PM Trudeau announced that we are increasing our target to a 40-45% drop in emissions from 2005 levels by 2030.

We have already made historic investments in climate action: over \$60 billion since 2015. In 2020, we laid out another \$15 billion through the Strengthened Climate Plan, and \$15 billion more for public transit.

Budget 2021 includes nearly \$18B in new investments to support a green recovery.

Davenport residents have made absolutely clear that they want our federal government to focus on a green recovery, and ensure our economic recovery does not come with a relapse into burning huge amounts of fossil fuels.

In December, we became one of the only countries to demonstrate a clear, specific plan on how we will actually reach our 2030 targets, laying out a strengthened climate plan called *A Healthy Environment and a Healthy Economy*.

Mark Carney, former Bank of Canada and Bank of England Governor and current UN Special Envoy on Climate Action and Finance, recently said in a speech that Canada is "the first country in the G20 with a carbon price policy serious enough to make a difference."

We also took bold action in Parliament by tabling our Canadian Net-Zero Emissions Accountability Act, which enshrines five year targets, right up to net-zero by 2050, into Canadian law.

With the Biden administration rejoining the Paris Accord, we are now coordinating with the U.S. to turbocharge our ambition. We are coordinating on trade action against countries failing to lower their emissions, on developing cross-border clean energy transmission and reaching net-zero power, on reducing oil and gas methane emissions, on protecting nature and approving nature-based climate solutions, on Indigenous-led conservation efforts, and on a zero-emission vehicle future.

#### Budget 2021 adds \$17.6 billion in brand-new green investments, which will:

- Create jobs in green tech, like manufacturing wind turbines, solar panels, electric cars, batteries, and more
- Spur Canadian innovation to build net-zero technologies and attract new investments in Canadian businesses
- Help lower emissions on farms and support agricultural climate solutions
- Invest in carbon capture technology
- Invest over \$400 million in natural infrastructure, like Toronto's ravines, which also provide walking and biking paths
- Help Canadians upgrade their homes to make them greener & more energy efficient
- Conserve 25% of our land and 25% of our water by 2025, supporting natural climate solutions and biodiversity

#### A MESSAGE FROM YOUR MP

Davenport Friends and Neighbours: Amis et voisins:

While the emphasis of this newsletter is on federal Budget 2021, rest assured that our attention as a federal government remains laser-focused on fighting COVID and supporting Canadians until we are well on the other side of this pandemic.

Federal Budget 2021 is over 700 pages, and this 6-page householder will not do justice to all the important items in it! If you would like a more in-depth look at what it contains, kindly visit canada.ca/budget.

The main objectives of Budget 2021 are to create jobs and grow the economy. Over the next few months, as more Canadians are vaccinated and the economy winds its way out of the COVID recession, the federal government will continue to offer robust small business supports and to extend supports for Canadians who are still looking for a job. Canada is among the most generous countries in the G7 as far as relief for small businesses, and this is purposeful—we want to do everything possible to give every small business a fair shot at making it through and bouncing back.

Growing the economy and investing for the future is core to Budget 2021. We will see growth thanks to the historic national childcare plan, measures for workers like increasing the federal minimum wage to \$15 and expanding the Canada Workers Benefit, and investments for small and medium-sized businesses to modernize and digitize. This will set the stage for a more competitive, productive and innovative economy.

Creating one million new jobs—a key goal of the budget—is core to Canada's green economy recovery. Investing in green technology, renewable energy, protecting 25% of Canada's land and water, and funding home retrofits, are all part of the plan to reduce our carbon emissions by 40-45% by 2030, and achieving net zero by 2050. Historic funding for public transit and active transportation (yes bike lanes and walking paths) will also help reduce emissions.

Budget 2021 significantly invests in our seniors, with a 10% increase to Old Age Security for everyone 75 and

#### **JOBS AND ECONOMIC GROWTH: PART 1**



#### A NATIONAL CHILDCARE SYSTEM

After 50 years of politicians talking about it, our federal Liberal government is taking action on national childcare. Budget 2021 introduces significant funding and a plan to ensure every Canadian family can access affordable childcare.

To accomplish this, we are investing

up to \$27 billion over the next five years, plus permanent federal funding for childcare, up to a total of \$9.2B per year by 2026. We will also invest \$29M to make childcare centres accessible to people with disabilities, and \$2.5B specifically for Indigenous childcare.

Cut fees by 50% on average by end of 2022

Reduce fees to \$10 a day by 2026

Establish affordable system of quality notfor-profit childcare across the country

#### **SUPPORT FOR CANADIAN WORKERS**

This budget will do more to support workers, through this pandemic and into the future-stimulating economic growth and increasing jobs:

- Extending the Canada Recovery Benefit (CRB) by an additional 12 weeks, to a maximum of 50 weeks (reducing to \$300 per week beginning July 17, when jobs are expected
- to be bouncing back)
- Making El simpler and more flexible for another year
- Substantially Increasing the Canada Workers Benefit, which will benefit about 1 million additional Canadians in low-wage jobs and lift 100,000 workers out of poverty
- Bringing in a \$15 federal minimum

wage—sending a signal to provinces that they should raise their own minimum wages

• Investing hundreds of millions to help workers retrain and upskill, including a new initiative for training for growing industries, one to help small businesses recruit the workers they need, and much more

#### **JOBS AND ECONOMIC GROWTH: PART 2**

#### SMALL BUSINESS: CORE TO CANADA'S ECONOMIC SUCCESS

Canada has provided the most generous relief for small businesses of any country in the G7, and this budget extends those programs. We know this is a really hard time for all small businesses, and though it breaks my heart to see empty storefronts, we know not every single business will make it through in the end. But we want to do everything possible to give everyone a fair shot.

#### **Investments to Help Small Business Modernize and Compete**

Budget 2021 introduces the new Canada Recovery Hiring Program. Through an investment of \$595 million, this new subsidy would help offset the extra costs employers take on as they reopen, either by increasing wages or hours worked, or hiring more staff. The program starts in June 2021 and ends in November 2021.

To help with the transition to digital platforms, we are also introducing the Canada Digital Adoption Program. This will help businesses adopt new technologies, plus create approximately 28,000 jobs for young Canadians and those taking on the role of digital trainers. The program includes \$1.4 billion over four years to provide access to skills and training services, and micro-grants for businesses. **Continued Emergency Supports**

Much Needed Support for Non-Profits and Charities. Budget 2021 invests \$400 million to create a Com-

munity Services Recovery Fund to help charities and nonprofits modernize and adapt as the economy reopens.



Budget 2021 includes \$523 million for airports and the airline industry to help with safe restart of air travel, including

creating Covid-19 testing infrastructure, more sanitization equipment, protection for passengers, limiting transmission, and creating safer, more secure air travel.

## **EMPOWERING BLACK CANADIANS**

Our federal Liberal government is working hard to break down the barriers that Black Canadians, racialized Canadians, and Indigenous Peoples face in our country-whether it's being denied a loan to start a business, or being profiled by police.

We have made significant investments to date in programs that benefit Black Canadians, in gathering better data about criminal justice and other outcomes for different racial groups, protecting communities from hate-based threats, and much more.

Budget 2021 makes significant new investments to build on this work. It will:

- Increase funding for the Black Entrepreneurship Program
- Empower Statistics Canada to gather better, disaggregated data and help us understand the gaps in our system better, including in the justice system

#### **SECURING GENDER EQUITY**

Canada cannot achieve gender equity without tackling gender-based violence. Our government has already invested hundreds of millions of dollars into womens' organizations since 2015, which has made a difference in Canada and in Davenport, but we need to do more—every 2.5 days a woman or girl is killed in Canada.

Our federal government is committed to making Canada a country free of gender-based violence. We are taking a huge leap forward with a National Action Plan to End Gender-Based Violence, and a commitment of \$600M:

- Funds for sexual assault centres, women's shelters, and other organizations that provide critical and often life-saving services and supports for women, girls, LGBTQ2, and gender non-binary people experiencing violence.
- Initiatives that make our communities more resilient to the threats of gender-based violence, including increased funding to stop human trafficking, support for at-risk populations and survivors, and initiatives that engage men and boys in recognizing the role they can play in ending gender-based violence.
- Better data collection around gender-based violence, so that the government can build stronger policies and take stronger action.

#### **TOWARDS A NEW NATION-TO-**NATION RELATIONSHIP

MAKING OUR STREETS SAFER

I am proud of the progress our government has made in the last five years towards reconciliation with **Indigenous Peoples.** We have made historic investments in Indigenous education and health care, we have lifted 106 long-term drinking water advisories (53 remaining), and we started implementing the Truth and Reconciliation Commissions' Calls To Action. We have made real progress to righting historic wrongs—but Canada still has a long path to walk.

In Budget 2021, we are investing an additional \$18 billion to close the infrastructure gap, and help Indigenous communities grow stronger, by:

- Continuing to support Indigenous communities' fight against COVID-19
- Improving health outcomes with investments in maintaining and improving health care systems
- Enabling Indigenous-led child care systems
- Building more infrastructure, including clean drinking water
- Facilitating business services and financing, including for Indigenous entrepreneurs
- Implementing a National Action Plan to meet the National Inquiry into Missing and Murdered Indigenous Women and Girls Calls for Justice
